## 1. What is this product?

<b>Type</b>	English law governed certificates
<b>Objectives</b> (Terms that appear in <b>bold</b> in this section are described in more detail in the table(s) below.)	The product is designed to provide a return in the form of a cash payment on the <b>maturity date</b> . The amount of this payment will depend on the performance of the <b>underlying</b> . The product has a fixed term and will terminate on the <b>maturity date</b> . If, at maturity, the <b>underlying</b> has fallen below the <b>initial reference level</b> , the product may return less than the <b>product notional amount</b> or even zero.  <u>Termination on the maturity date:</u> On termination of the product on the <b>maturity date</b> , you will receive a cash payment directly linked to the performance of the <b>underlying</b> . The cash payment will equal (i) the <b>product notional amount</b> multiplied by (ii) (A) the <b>final reference level</b> divided by (B) the <b>initial reference level</b> .

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.  
The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlying**, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

<b>Underlying</b>	The <b>underlying</b> is the AtonRâ Sustainable Future (EUR) Strategy (Bloomberg: JMLNARSE Index) which provides you with variable exposure to the performance of the <b>sub-strategy</b> and to the <b>cash index</b> . This variable exposure can range from 0% to 100%. The <b>sub-strategy</b> consists of a basket of <b>constituents</b> which includes shares in the Sustainable Development sector listed on global exchanges and the <b>cash index</b> . The <b>allocator</b> aims to achieve a positive return for the <b>underlying</b> over the medium to long term through adjusting the exposure to the <b>sub-strategy</b> and adjusting the composition of, and exposure to, the shares within the <b>sub-strategy</b> . The <b>allocator</b> may also allocate to the <b>cash index</b> at the <b>underlying</b> and <b>sub-strategy</b> level. To achieve this at the <b>sub-strategy</b> level, the <b>allocator</b> decides which <b>constituents</b> are included in the <b>sub-strategy</b> contained within the <b>underlying</b> upon launch and may change the composition of the <b>underlying</b> from time to time, as well as the exposure to the <b>constituents</b> . Any <b>allocator</b> selection must meet certain restrictions which may limit the eligible <b>constituents</b> and their weightings in the <b>underlying</b> . Investors should satisfy themselves as to the ability of the <b>allocator</b> to achieve its aim. The <b>allocator</b> is paid a fee of 1.30% per annum plus a performance fee of 15% per annum. The product issuer is paid a fee of 0.20% per annum.

The level of the **underlying** is based on the weighted returns of the **constituents** and the exposure to the **sub-strategy** and to the **cash index**. The level of the **underlying** will also take into account a deduction on each rebalancing of the exposure to and within the **sub-strategy** to the **constituents**, referred to as the rebalancing adjustment factor, other running adjustment factors referred to as the index allocator adjustment factor and strategy adjustment factor, foreign exchange conversion rates and dividends, in each case if relevant for the **constituents**. Further information on how the **underlying** is determined is set out in the **strategy rules** (see "Other Relevant Information" below). The **strategy rules** give various powers to the strategy sponsor and calculation agent of the **underlying** including the discretion to adjust its terms or terminate the **underlying**. ### Recommended holding period: 9 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 6 November 2028 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
